## Real Property Tax Credit (IT-214)

You may be eligible for a real property tax credit (IT-214). If your 2011 household income including social security, wages, pension, interest, and other income was less than \$18,000, *you must bring the* Mortgage Interest Statement (Form 1098) that you received from the Co-op Office as well as the documents listed above to the NORC Office.

You may also qualify to file a claim for the NYC School Tax Credit (NYC-210), if you have lived in the City of New York for all or part of 2011 and you cannot be claimed as a dependent on another taxpayer's federal tax return.
